

END-USER SOFTWARE LICENSE AGREEMENT

This End User License Agreement (“EULA”) is entered into between Status Solutions LLC, having offices at 1180 Seminole Trail, Suite 440, Charlottesville, Virginia 22901 (hereinafter, “Status”) and “You”.

As used herein, “You” is the person or entity that purchased certain equipment from Status (the “Equipment”) which contains the “Software”. As used herein, the “Software” is the software owned by Status (and/or its suppliers) which is embedded in the Equipment; this EULA relates to such Software. The term “Software” includes all associated software components, media, printed materials, and “online” or electronic documentation and all modifications, enhancements, corrections or upgrades thereto.

This EULA is a legal agreement binding upon You and governing your use of the Software. By installing, copying or otherwise utilizing the Software, you agree to be bound by the terms of this EULA.

THIS END USER SOFTWARE LICENSE AGREEMENT, ONCE YOU INSTALL, COPY OR OTHERWISE ACCESS OR UTILIZE THE SOFTWARE, BECOMES A LEGALLY BINDING AGREEMENT GOVERNING YOUR RIGHT, AND THE LIMITED EXTENT OF YOUR RIGHT, TO USE THE SOFTWARE. Upon payment by you of the purchase price of the Equipment and any and all related fees, costs and expenses related thereto, including the license fees payable relative to the license to You of the Software, Status hereby grants to You a non-exclusive license (the "License"), limited to the United States and Canada, in and to the Software, in machine-readable object code format only, to utilize the Software solely with the Equipment, but only in accordance with the provisions hereof. No ownership rights of any kind or to any extent are conveyed by this EULA or incident to the License to You or to any other party. All rights not expressly granted herein are reserved to Status and, where applicable, to its suppliers.

2. BACKUP AND ARCHIVAL COPIES. The License granted to You relative to the Software includes the right to make one copy of the Software, but solely for backup and archival purposes, provided that such copy shall contain all Intellectual Property Notices. As used herein, "Intellectual Property Notices" are any and all notices embedded in, on or relating to the Software, including but not limited to copyright, patent, trade secret, trademark or any and all other intellectual property rights.

3. OWNERSHIP OF THE SOFTWARE. You agree and acknowledge that the Software is owned by Status (and/or where applicable, its suppliers), and accordingly You have no right, and You acknowledge that no such right is granted hereby, to use, make, sublicense, modify, transfer, rent, lease, sell, display, distribute or copy originals or copies of the Software, or to permit or authorize any other party to do so, except as may be specifically permitted by the express terms of this EULA.

4. PROHIBITION ON TRANSFER/ASSIGNMENT. You hereby acknowledge and agree that You are prohibited from transferring or assigning any rights set out in this EULA or any rights to the Software or to the License without the express prior written consent of Status, which consent may be withheld in Status' sole discretion.

5. "SARA's EMESSENGER LIMITATIONS. Status' Situational Awareness Response Assistant ("SARA") "eMessenger" Software is designed for use on a dedicated, "closed-end" wireless fidelity ("Wi-Fi") system, being a system which cannot be expanded once initially configured, and in conjunction with cellular voice and data connectivity and only in conjunction with Apple's iOS 9 (or higher) running on an iPhone that can be made to be both Wi-Fi and cellular enabled (collectively, an "Approved Device"). Without expanding on the limitations of warranty and liability set out in paragraphs 11 and 12 hereof, You are advised that eMessenger may not function or may not function properly on "open-end" Wi-Fi systems that have applications added after initial set up of the eMessenger Software or as to which any devices are utilized other than an Approved Device or on devices that do not also include cellular voice and data connectivity. Status Solutions cannot be held liable for the use of unapproved devices and/or device connectivity methods.

specific instructions provided to You by Status in writing, and then in all cases only in those operational environments where there are redundant systems and/or backup procedures/policies/programs, especially in those environments or applications where personal injury, including death, or damage to or loss of property or business information/interests would or could occur from a malfunction of the Software.

7. PROHIBITION ON REVERSE ENGINEERING, ETC. YOU AGREE THAT YOU WILL NOT REVERSE ENGINEER, DECOMPILE, DISASSEMBLE, UNENCRYPT OR OTHERWISE TRANSLATE THE SOFTWARE OR ALLOW ANY OTHER PARTY TO DO SO.

This licensing policy is in effect to ensure each customer receives the proper and paid for warranty obligations and service options from Status. In the event that a foreign device license is utilized in conjunction with your use or operation of SARA, Status’ foreign device licensing policy states that a one-time fee per such foreign device will be assessed. A breach of this device license policy is a breach of this EULA and is subject to any legal ramifications as set forth herein or as otherwise permitted by law. You hereby agree, in the event of any breach or other violation of this EULA wherein it becomes necessary for Status to incur any expense to enforce or interpret the terms of this EULA (regardless of whether suit is instituted or not), that you will reimburse Status all cost and expense it incurs associated therewith, including attorneys' and expert witness fees, and all direct costs, including but not limited to all court costs.

BY INSTALLING AND USING THE SOFTWARE, YOU ARE CONFIRMING YOUR ACCEPTANCE OF THE SOFTWARE AND AGREEING TO BECOME BOUND BY THE TERMS OF THIS AGREEMENT. IF YOU DO NOT AGREE TO BE BOUND BY THESE TERMS, THEN DO NOT INSTALL THE SOFTWARE AND RETURN THE SOFTWARE TO YOUR PLACE OF PURCHASE FOR A FULL REFUND. 1. Definitions

- (a) "Not For Resale (NFR) Version" means a version, so identified, of the Software to be used to review and evaluate the Software, only. The NFR Version may have limited features, and may cease operating after a predetermined amount of time due to an internal mechanism within the NFR Version.
- (b) "Software" means only the VSS program(s) supplied by VSS herewith, and corresponding documentation, associated media, printed materials, and online or electronic documentation.

2. License Grants

The licenses granted are subject to the terms and conditions set forth in this EULA:

- (a) Subject to the terms and conditions of this Agreement, VSS hereby grants, and you accept, the right and license to install and use the Software on a single computer. A license for the Software may not be shared, installed nor used concurrently on different computers.
